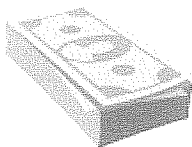


#### GENERAL INFORMATION

Thank you for participating in the UGI Save Smart Energy Efficiency rebate program! UGI offers a variety of incentives to help our customers lower their energy bills through the use of high efficiency equipment.

- Valid for UGI-Gas customers who install qualifying residential and commercial heating and water heating between January 1, 2017 - September 30, 2021.
- Valid for UGI-PNG customers who install qualifying residential and commercial heating and water heating equipment between January 1, 2018- September 30, 2022.
- **These rebates and programs are available to UGI Gas and UGI-PNG customers only. UGI-CPG customers are not eligible for these rebates. Your eligibility will be verified by zip code once you enter your account information on this application. We are working on implementing more programs for our other service territories. - The rebate application must be submitted along with a copy of an itemized invoice showing the manufacturer, model #, quantity and total price showing full payment made. For commercial rebates over \$600, a completed W-9 form must be included with the application.

## REBATE APPLICATION INSTRUCTIONS

2. Purchase and install the qualifying equipment. Must be purchased and installed between October 1, 2018 and September 30, 2019.

3. Return the completed application along with the following items:

  - Equipment Manufacturer
  - Model Number
  - Date of Purchase
  - Contractor Information
  - Equipment & Installation Cost

## PROGRAM DETAILS

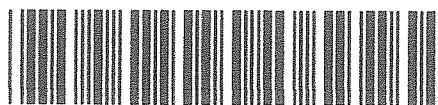
