# AMENDMENT I to DUPONT BOROUGH TRAFFIC CODE ORDINANCE

AN ORDINANCE REGULATING THE PARKING AND OPERATING OF VEHICLES AND OTHER MOVING OBJECTS AND DEVICES UPON OR ACROSS THE STREETS AND HIGHWAYS OF THE BOROUGH OF DUPONT DURING SNOW AND ICE EMERGENCIES, PROVIDING FOR THE RECORDING OF CERTAIN VIOLATIONS OF SUCH REGULATIONS AND PROVIDE FOR THE UPRGRADING OF CERTAIN

the Borough of Dupont of Luzerne County is interested in maintaining the health, safety and welfare of its citizens;

and be it ordained and enacted by the Council of the Borough of Dupont, Luzerne County, Pennsylvania, and it is hereby ordained and enacted by the authority of the same as follows:

## ARTICLE I: GENERAL PENALTY EXCEPTION

Section 1: Article IV, Section 5. Exception is hereby corrected "Fines and penalties..... will supersede Article IV, Section 4, when....in the Section 4.

### ARTICLE II: PROHIBITED PARKING

Section 1: After any snowfall of three (3) inches or more: By 7 AM it will be unlawfull for any person to park a vehicle on designated sides of Streets. From 7 AM-5 PM on the first day after the snowfall there will be no parking on the **EVEN** numbered side of the streets to facilitate clearing of snow. The following day the ODD numbered side of the street will be designated as a no-parking zone for clearing of snow. Vehicles not removed on DESIGNATED DAYS for snow removal will be ticketed and towed at owners'

# Article III: OTHER PROHIBITED ACTS:

Section 1: Everyone is required to Clean their sidewalks of snow within FOURTY EIGHT (48) hours following the end of the snowfall.

Section 2: It will be illegal for anyone to throw snow onto the roadway when clearing driveways or sidewalks.

Section 3: Anyone hiring a private contractor to remove snow is responsible for placing all snow onto private Section 4:

Piling of snow at intersections is not permitted.

Fire hydrants must be kept clear of snow at all times.

#### ARTICLE IV: PENALTIES:

Section 1: If at anytime a sidewalk has not been cleared of snow within FOURTY EIGHT (48) hours of the end of snowstorm, the person shall be guilty of a violation of this Part and shall pay a fine of \$15.00 per day, not to exceed \$300.00.

Section 2: Violation of ARTICLE III, Section 2 shall be guilty of violation of this Part and shall pay a fin between \$25.00 and \$300.00, not to exceed \$300.00.

#### Section 3:

Fines and penalties provided in the State Motor Vehicle Code will supersede  $\Lambda$ rticle VIII, when such fines and penalties are in excess of those permitted in the section.
